Dear Partner,


This is to inform you that GIZ Uganda received letters from its key implementation partners, the Office of the Auditor General (OAG) and the National Planning Authority (NPA), requesting a temporary pause in the current activities under the Strengthening Governance and Civil Society Programme (GCSP) to allow the Attorney General to provide requisite clearance of the implementation agreement.

As the agreement forms the legal basis for implementation of GIZ's activities under GCSP, current GCSP activities are to be temporarily paused until we have obtained the requisite clearance. This includes current activities implemented under the Civil Society in Uganda Support Programme and the Strengthening and Advancing Governance and Accountability Programme.

GIZ understands that this decision has implications for your organisation and the activities that are currently under implementation or are planned. We appreciate your flexibility and understanding.
